PODPOL18 Standards of Dress Policy

1. Policy Introduction and Background:

Merseyside Fire and Rescue Service (MF&RS) sets out the standards of dress required of every member of staff in its Standards of Dress Procedure.

MF&RS recognises that society has changing fashions and styles; however MF&RS is a uniformed public sector organisation providing important services to the communities of Merseyside. Each member of staff is a representative of MF&RS. We require all members of staff to keep a smart and professional appearance when they are at work or at work-related functions. Unconventional or extreme styles of dress/appearance, including, haircuts are not permitted.

2. Policy Explanation:

Personnel are provided with a range of uniform or corporate wear depending upon their role. Employees who may be working, or have the potential to work, in a safety critical environment, such as a fireground, must adhere to certain specified personal safety procedures regarding facial hair and must wear their personal protective clothing correctly at all times in order to ensure their health, safety and welfare. Office based staff must ensure that their appearance is smart, clean and professional

Uniform worn by staff on-duty may comprise of items provided by MF&RS only. Uniform may not be worn by off-duty staff, except when proceeding to and from duty or on other occasions approved beforehand by the Chief Fire Officer or their nominee. A mixture of personal dress and uniform is permitted when travelling to and from duty provided that the overall effect is smart and in keeping with a uniformed public service image.

Particular items of uniform or corporate clothing can be provided in order to meet the needs of pregnant women staff or staff with particular cultural or religious needs which also meet the needs of MF&RS.

It is the responsibility of each member of staff to maintain their uniform, corporate wear or personal clothing in a clean, smart and serviceable condition.

MF&RS sets out its current uniform and corporate clothing detail in its Standards of Dress Service

Instruction. The Instruction also specifies the personal safety requirements regarding hair, facial hair, jewellery and cosmetics for those working in a safety critical environment.
